Dear Campership Applicant,


Thank you for your interest in Camp Good News. The Campership Program makes donated funds available to help cover the cost of camp for children who couldn't otherwise attend. Because the funds are limited we feel it is necessary to allocate Campership donations to those who have the greatest need for assistance. Therefore, we request you fill out the "2017 Camp Good News Campership Application" on the reverse side of this letter to help us in determining your child's need. Please return it to us as soon as possible since allocations are made as donations come in.

A \$110.00 deposit and completed registration form for each child for whom a Campership is requested MUST accompany this Campership application. This \$110.00 deposit must be paid by you so that we can spread out the limited funds to as many children as possible. If the child is accepted and should have to cancel prior to camp, the deposit will be refunded **if cancellation is made two weeks prior to the first day of your child's camp session or, the space is filled.** **PLEASE NOTE: If your application is DENIED your \$110.00 deposit WILL BE RETURNED to you.**

For those not awarded a Campership, other options to reduce the cost of camp include: the multiple child from one family discount and, the Workership Program where Christians may apply to work at camp and request a \$90.00 discount for the child of their choice—if a **financial need is evident**, these are extremely limited. For more information about these programs, please call the camp office weekdays at 461-1146.

If your child is awarded a Campership, please encourage him/her to write a thank you note to the donor. The name of the donor will be provided to you on your child's Camper Registration Confirmation form which you will receive in the mail. We request that you mail us the thank you note so that we can forward it on to the donor.
